Engagement and Scope of Services:

Company hereby engages Ambassador, and Ambassador accepts engagement, to promote Company's products and services under the terms set forth in this Agreement. Ambassador agrees to use best efforts, skills, and abilities to market, advertise, and generate leads or sales for Company within the designated territory or audience.

Term and Termination:

The term of this Agreement shall commence upon execution and continue until terminated by either party upon written notice. Termination may occur at any time with or without cause by either party by providing at least thirty (30) days advance written notice. Termination shall not affect obligations or liabilities incurred prior to termination.

Compensation:

Ambassador agrees to maintain the confidentiality of all non-public information obtained in connection with this Agreement, including business plans, customer data, and proprietary materials. This obligation shall survive termination of this Agreement.

Intellectual Property:

All intellectual property rights in materials provided by Company remain the sole property of Company. Ambassador shall not claim any ownership or use such materials except as expressly permitted herein. Any works created by

Ambassador specifically for Company under this Agreement shall be considered works made for hire and owned exclusively by Company.

Compliance with Laws:

Ambassador shall comply with all federal, state, and local laws, regulations, and ordinances applicable to the performance of services under this Agreement, including but not limited to advertising, marketing, and privacy laws.

Indemnification:

Ambassador agrees to indemnify, defend, and hold harmless Company and its officers, directors, employees, and agents from any and all claims, damages, liabilities, costs, and expenses arising out of Ambassador's breach of this Agreement, negligence, or willful misconduct.

Limitation of Liability:

In no event shall Company be liable for any indirect, incidental, consequential, special, or punitive damages arising out of or related to this Agreement, even if advised of the possibility of such damages.

Non-Solicitation:

During the term of this Agreement and for a period of one (1) year thereafter, Ambassador shall not solicit or attempt to solicit any customer or employee of Company for the purpose of providing products or services competitive with those of Company.

Governing Law and Dispute Resolution:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to its conflict of law principles. Any disputes arising under or in connection with this Agreement shall be resolved exclusively in the state or federal courts located in _____ County, _____. The parties waive any right to a jury trial to the maximum extent permitted by law.

Entire Agreement and Amendments:
