1. Proposal shall include all relevant specifications, drawings, or data necessary for evaluation. 2. Bidder must comply with all specifications and legal requirements stated herein. 3. Any bids not conforming to stated requirements may be rejected without further consideration. 4. The bid shall remain valid and binding for a period no less than 60 calendar days from submission deadline. 5. Bidders must provide evidence of all licenses, permits, and certifications required to perform the work.

Evaluation Criteria:

Bids will be evaluated based on price, compliance with specifications, delivery schedule, warranty, and bidder's demonstrated capability and experience. The Owner reserves the right to accept or reject any bid, to waive informalities, and to award the contract in the best interest of the Owner.

Bid Validity and Withdrawal:

Bids submitted shall be irrevocable for the period of bid validity. Withdrawal or modification of bids after the submission deadline is not permitted unless otherwise stated in writing by the Owner. Late bids will not be considered under any circumstances.

Contract Award and Execution:

Upon acceptance of a bid, the Owner will issue a formal contract award. The successful Bidder shall execute the contract and provide all required bonds, insurance certificates, and documentation within the time frame specified in the contract documents.

Disclaimers and Liability:

The Owner shall not be responsible for any costs incurred by bidders in the preparation or submission of bids. The

Owner makes no representations or warranties, express or implied, regarding the bidding process or the contract award. Bidders shall indemnify and hold harmless the Owner from any claims arising from the bidding process.

Governing Law and Jurisdiction:

This Bid Template and any resulting contract shall be governed by and construed in accordance with the laws of the United States and the applicable state laws without regard to conflict of law provisions. The parties consent to the exclusive jurisdiction and venue of the federal and state courts located within the appropriate jurisdiction.
