Clause 1 – Purpose of Agreement

Seller agrees to sell and Buyer agrees to purchase the custom furniture described above on the terms set forth in this Agreement. Seller represents that Seller has full right and authority to sell the described furniture and that no third party consent is required except as expressly stated herein.

Clause 2 – Specifications and Customization

Seller shall manufacture or procure the furniture as per the specifications, materials, dimensions, and design detailed in this Agreement or attached exhibits. Any changes requested by Buyer must be agreed in writing and may affect price and delivery timelines.

Clause 3 – Delivery and Installation

Seller shall deliver and, if agreed, install the furniture at the specified location in a timely manner, subject to reasonable delays caused by events outside Seller’s control. Risk of loss passes to Buyer upon delivery and acceptance.

Clause 4 – Purchase Price and Payment

Buyer shall pay the Purchase Price as specified, including any deposits. Final payment shall be made upon delivery or completion of installation as agreed. Late payments may incur interest at the maximum rate permitted by law.

Clause 5 – Warranties

Seller warrants that the furniture will be free of defects in material and workmanship for a period of one year from delivery. This warranty does not cover damage caused by misuse, abuse, normal wear and tear, or unauthorized modifications.

Clause 6 – Inspection and Acceptance

Buyer shall inspect the furniture promptly upon delivery. Any defects or non-conformities must be reported in writing within 7 days. Failure to notify Seller shall be deemed acceptance.

Clause 7 – Returns and Remedies

Custom furniture is non-returnable except for defects covered under the warranty. Seller’s sole obligation shall be repair or replacement at Seller’s option. Buyer’s remedies are limited to those expressly stated in this Agreement.

Clause 8 – Taxes and Fees

Buyer shall be responsible for all applicable sales, use, excise, or other taxes related to the purchase, except for taxes based on Seller’s income.

Clause 9 – Title and Risk of Loss

Title to the furniture remains with Seller until full payment is received. Risk of loss passes to Buyer upon delivery and acceptance.

Clause 10 – Intellectual Property

Any designs, plans, or customizations remain the intellectual property of Seller unless otherwise agreed in writing.

Clause 11 – Confidentiality

The parties agree to keep all proprietary information exchanged in connection with this Agreement confidential.

Clause 12 – Limitation of Liability

Seller’s liability shall be limited to direct damages up to the amount paid by Buyer. Seller shall not be liable for indirect, incidental, or consequential damages.

Clause 13 – Force Majeure

Neither party shall be liable for delays or failure to perform due to causes beyond reasonable control including acts of God, strikes, or government actions.

Clause 14 – Governing Law and Venue

This Agreement shall be governed by the laws of the State of _____ without regard to conflict-of-law principles. Any disputes shall be resolved exclusively in the courts located in _____ County, _____.

Clause 15 – Entire Agreement

This Agreement constitutes the entire understanding between the parties and supersedes all prior discussions and agreements. Amendments must be in writing and signed by both parties.

Clause 16 – Severability

If any provision is found unenforceable, the remaining provisions shall remain in full force and effect.

Clause 17 – Notices

All notices shall be in writing and deemed delivered when sent by hand, certified mail, overnight courier, or by electronic means with confirmation, to the addresses specified above.

Clause 18 – Assignment

Neither party may assign this Agreement without prior written consent from the other party.

Clause 19 – Waiver

Failure to enforce any provision shall not constitute a waiver of future enforcement.

Clause 20 – Signatures; Counterparts

This Agreement may be executed in counterparts, each of which shall be deemed an original and together constitute one instrument.
