Clause 1 – Purpose and Scope of Endorsement

Endorser hereby endorses to Endorsee all rights, title, and interest in and to the Contract referenced above, subject to the terms and conditions herein. This endorsement is made voluntarily, without duress or undue influence.

Clause 2 – Representations and Warranties

Endorser represents and warrants that (a) they are the lawful owner or authorized representative of the rights being endorsed; (b) the Contract is valid, binding, and enforceable under the laws of the United States; (c) the rights endorsed are free from all liens, encumbrances, or claims by third parties; and (d) they have full authority to make this endorsement.

Clause 3 – Effectiveness and Binding Nature

This endorsement shall become effective immediately upon execution by Endorser and shall be binding upon the parties and their respective heirs, successors, and assigns.

Clause 4 – Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with the laws of the United States and the applicable State law where the Contract was initially executed. The parties consent to the exclusive jurisdiction of the courts located in the relevant State.

Clause 5 – Indemnification

Endorser agrees to indemnify, defend, and hold harmless Endorsee from any and all claims, damages, liabilities, or expenses arising out of any breach of the representations and warranties contained herein.

Clause 6 – Notices

All notices related to this endorsement shall be in writing and delivered by hand, certified mail, nationally recognized overnight courier, or electronic means capable of confirming transmission and receipt, to the addresses provided herein.

Clause 7 – Entire Agreement

This Endorsement Contract Agreement constitutes the entire agreement between Endorser and Endorsee with respect to the subject matter hereof and supersedes all prior agreements, understandings, or representations.

Clause 8 – Amendments

No amendment or modification of this Agreement shall be valid unless made in writing and signed by both parties.

Clause 9 – Severability

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall continue in full force and effect.

Clause 10 – Counterparts and Execution

This Agreement may be executed in counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same instrument. Electronic signatures shall be deemed valid and binding.
