Clause 1 – Membership Grant

The Organization hereby grants to the Member a non-transferable membership, subject to the terms and conditions set forth herein. Membership benefits and privileges are as described in this Agreement and any attached Schedules.

Clause 2 – Term and Renewal

The Membership term shall be for the period specified above. Membership may be renewed subject to Organization policies and payment of applicable fees. No automatic renewal shall occur unless expressly agreed in writing.

Clause 3 – Fees and Payment

Member agrees to pay all membership fees and any other charges as described. Failure to pay timely may result in suspension or termination of membership. All payments are non-refundable except as otherwise provided.

Clause 4 – Member Obligations

Member agrees to abide by all applicable rules, regulations, and policies of the Organization, which may be amended from time to time. Member shall conduct themselves in a manner consistent with the Organization's code of conduct.

Clause 5 – Suspension and Termination

The Organization reserves the right to suspend or terminate membership for cause, including but not limited to violation of rules, non-payment, or conduct detrimental to the Organization. Termination shall not relieve Member of any outstanding obligations.

Clause 6 – Liability and Indemnification

Member agrees to release, indemnify, and hold harmless the Organization and its affiliates from any claims, damages, or liabilities arising out of Member's participation or use of Organization facilities, except to the extent caused by Organization's gross negligence or willful misconduct.

Clause 7 – Privacy and Personal Information

The Organization will collect, use, and store Member's personal information in accordance with applicable law and its privacy policy, solely for purposes related to membership administration and communication.

Clause 8 – Governing Law and Venue

This Agreement shall be governed by the laws of the State of _____ without regard to conflict of law principles. Any disputes shall be resolved exclusively in the courts located in _____ County, _____.

Clause 9 – Entire Agreement

This Agreement represents the entire understanding between the parties with respect to membership and supersedes all prior communications. Any amendments must be in writing and signed by both parties.

Clause 10 – Severability

If any provision is held invalid or unenforceable, the remaining provisions shall remain in full force and effect and be construed in a manner consistent with the original intent.

Clause 11 – Waiver

Failure or delay by either party to enforce any term shall not constitute a waiver of that term or any other rights under this Agreement.

Clause 12 – Notices

All notices shall be in writing and deemed delivered when received by hand, certified mail, overnight courier, or confirmed electronic transmission, to the addresses provided by the parties.

Clause 13 – Assignment

Member may not assign or transfer this Agreement or any rights hereunder without the prior written consent of the Organization.

Clause 14 – Counterparts and Electronic Signatures

This Agreement may be executed in counterparts and by electronic signature, each of which shall be deemed an original, but all constituting one and the same instrument.

Clause 15 – Dispute Resolution

The parties shall attempt to resolve disputes amicably through negotiation prior to initiation of any legal proceedings.

Clause 16 – Force Majeure

Neither party shall be liable for delays or failure to perform due to causes beyond their reasonable control, including natural disasters, acts of government, or other force majeure events.

Clause 17 – Membership Benefits Subject to Change

The Organization reserves the right to modify membership benefits and privileges upon reasonable notice to Member.

Clause 18 – Confidentiality

Member agrees to keep confidential any proprietary information received through membership and not to disclose it to third parties.

Clause 19 – Compliance with Laws

Member agrees to comply with all applicable federal, state, and local laws and regulations in connection with membership.

Clause 20 – Signatures

The parties have executed this Membership Contract Agreement as of the Effective Date set forth above.
