Clause 1 – Agreement to Sell and Purchase

The Seller agrees to sell and the Buyer agrees to purchase the goods or services described above, on the terms and conditions set forth in this Agreement.

Clause 2 – Condition and Inspection

The Buyer acknowledges having inspected the goods and accepts them 'as is' and 'where is' without any warranties other than those expressly stated herein, subject to any applicable Australian consumer law.

Clause 3 – Delivery

Delivery of the goods shall occur at the location agreed upon by the parties, with risk of loss passing to the Buyer upon physical delivery or collection.

Clause 4 – Purchase Price and Payment

The Purchase Price is payable in Australian Dollars as specified above. Payment shall be made by the agreed method and schedule. Late payments may incur interest as prescribed by law.

Clause 5 – Title and Risk

Title in the goods shall pass to the Buyer upon full payment of the Purchase Price. Risk passes upon delivery as set out in Clause 3.

Clause 6 – Warranties and Liability

Except as expressly provided, no warranties are given. The Seller's liability is limited to the remedies expressly provided in this Agreement and as required by law.

Clause 7 – Taxes and Charges

The Buyer is responsible for all applicable taxes, duties, fees, and charges arising from the purchase and ownership of the goods.

Clause 8 – Default and Termination

If either party breaches any material term and fails to remedy the breach within a reasonable time after notice, the non-breaching party may terminate this Agreement.

Clause 9 – Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with the laws of the State or Territory in Australia where the goods are delivered. The parties submit to the exclusive jurisdiction of its courts.

Clause 10 – Entire Agreement

This Agreement constitutes the entire agreement between the parties and supersedes all prior negotiations and understandings.

Clause 11 – Amendments

No amendment to this Agreement is effective unless in writing and signed by both parties.

Clause 12 – Notices

All notices must be in writing and delivered personally, by prepaid post, or by email to the addresses set out in this Agreement.

Clause 13 – Severability

If any provision is invalid or unenforceable, the remainder of this Agreement remains in full force and effect.

Clause 14 – Counterparts

This Agreement may be executed in counterparts, each of which shall be deemed an original but all of which together constitute one and the same instrument.

Clause 15 – Privacy

The parties agree to handle all personal information in compliance with applicable privacy laws and regulations.

Clause 16 – Force Majeure

Neither party shall be liable for delays or failure to perform due to causes beyond their reasonable control.
