Warranty Terms and Conditions:

This Limited Warranty (“Warranty”) is provided by the Warranty Provider to the Warranty Holder subject to the terms and conditions set forth herein. The Warranty covers defects in material and workmanship under normal use and service. The Warranty Provider agrees to repair or replace, at its option, any covered product or component that fails due to such defects during the Warranty Period. This Warranty is non-transferable and applies only to the original Warranty Holder.

Warranty Period:

The Warranty Period shall commence upon the date of purchase and shall continue for a period of: _____ months

Exclusions and Limitations:

This Warranty does not cover damages resulting from accident, misuse, abuse, neglect, unauthorized modification or repair, improper installation, normal wear and tear, or external causes such as fire, flood, or other acts of God. Consumable parts such as batteries, filters, and bulbs are excluded. Any implied warranties, including warranties of merchantability or fitness for a particular purpose, are limited in duration to the term of this express Warranty.

Claim Procedure:

To make a claim under this Warranty, the Warranty Holder must notify the Warranty Provider in writing within thirty (30) days of discovery of the defect. Proof of purchase and reasonable cooperation are required. The Warranty Holder shall bear the cost of transportation to and from the Warranty Provider’s facility, unless otherwise agreed in writing. The Warranty Provider may require inspection or testing prior to approval of any claim.

Limitation of Liability:

IN NO EVENT SHALL THE WARRANTY PROVIDER BE LIABLE FOR ANY INCIDENTAL, CONSEQUENTIAL, INDIRECT, OR SPECIAL DAMAGES ARISING OUT OF OR IN CONNECTION WITH THE PRODUCT OR THIS WARRANTY, INCLUDING BUT NOT LIMITED TO LOSS OF PROFITS, LOSS OF USE, OR DAMAGES TO PROPERTY. THE WARRANTY PROVIDER'S LIABILITY SHALL NOT EXCEED THE PURCHASE PRICE PAID FOR THE PRODUCT.

Governing Law and Jurisdiction:

This Warranty shall be governed by and construed in accordance with the laws of the United States and the state where the Warranty Provider is located, without regard to conflict of law principles. Any disputes arising out of or relating to this Warranty shall be subject to the exclusive jurisdiction of the state or federal courts located therein.

Severability:

If any provision of this Warranty is found to be invalid, illegal, or unenforceable, the remaining provisions shall continue in full force and effect. The invalid provision shall be replaced by a valid provision that most closely reflects the parties' original intent.

Entire Agreement and Amendments:

This Warranty constitutes the entire agreement between the parties regarding the subject matter herein and supersedes all prior agreements and understandings, whether written or oral. Any modifications or amendments must be in writing and signed by both parties to be effective.
